### **BHS Systemwide Databook (MH & SUD), FY 2023-24**

This report provides a comprehensive overview of various mental health services across different populations and service types. It includes demographic and discharge data for perinatal clients, individuals involved in driving under the influence (DUI), and those receiving SUD treatment. It further outlines the utilization of mental health services for children and youth (CY), as well as adults, detailing services such as outpatient, intensive outpatient, residential, inpatient, crisis, and case management. Specific attention is given to transition-age youth and older adults within the adult category, highlighting their demographic data and service usage. The report aims to present key trends and insights to guide decision-making and improve mental health service delivery across different age groups and service needs.

The Mental Health Services Act (MHSA) system of care for San Diego County Behavioral Health Services (SDCBHS) aims to create a more accessible and timely service system that reduces reliance on out-of-home and institutional care, while eliminating stigma associated with serious mental illness (SMI) and serious emotional disturbance (SED). The County's MHSA Three-Year Plan was developed with input from community partners and stakeholders. The Prevention and Early Intervention (PEI) component of the MHSA system focuses on strategies to prevent negative outcomes from untreated mental illness, while raising mental health awareness through public education and training initiatives. This report provides an overview of the MHSA PEI outcomes, methodology, and results from the past three years, as required by MHSA regulations.
