# **Provider Tips**

These tips are to aid in the process of completing the CANS/PSC tools. Please see the prior notification sent to providers with more detail located <a href="https://example.com/here">here</a> on our website at <a href="https://example.com/www.optumsandiego.com">www.optumsandiego.com</a>.

Providers must complete the CANS certification prior to administering the CANS tools.

Effective July 1, 2019, The County of San Diego is mandated by the State to implement and manage tools to measure treatment outcomes. The Child and Adolescent Needs and Strengths (CANS) and the Pediatric Symptom Checklist (PSC - 35) are the new outcome tools for the County of San Diego Mental Health Plans for all new youth ages 0 - 21 entering services.

## Who needs to complete the CANS outcomes tools:

All providers rendering **therapy** services to youth ages 0 - 21 must complete the following tools when applicable:

### What needs to be completed:

- SD CANS EC by provider for youth ages 0 5 years of age
- SD CANS by provider for youth ages 6 21 years of age
- PSC by caregiver of youth 3-18 years of age
- PSC-Y by youth 11-18 years of age

### San Diego Child and Adolescent Needs and Strengths - Early Childhood (SD CANS-EC)

- M SD CANS-EC, v.6/2019 (TO BE ADMINISTERED EFFECTIVE 7/1/2019 FOR CHILDREN AGES 0-5)
- M SD CANS-EC Manual, v.6/2019

### CANS/PSC tools must be completed and submitted to Optum:

- With Initial Authorization Requests (or ITP)
- With Continued Authorization Request (or TPU) or every 6 months (whichever occurs first)
- Upon discharge

#### **PROVIDER STEPS:**

- 1. Provider must be CANS Certified (San Diego CANS 1.0)
- Provider will administer CANS as outlined on previous page. CYF mHoms Client Information Sheet with required fields. Example of Client Information Sheet with required fields highlighted is located on our Optum website.
- Provider will collect the PSC and PSC-Y (when applicable) from youth and caregiver as outlined on previous page
- Provider will submit the CYF mHOMS Client Information Sheet, CANS, and PSC tools to Optum for data entry and tracking
- 5. Provider will receive reports on past due tools
- 6. Provider may need to complete Provider/Family Letter to have in client file (TBD once a determination is made you will be notified)
- 7. Provider will receive reports from outcome data to review and utilize in treatment planning
- 8. Provider will be recertified for the CANS on a yearly basis (1x per year)

The Fee-For-Service (FFS) Provider Operations Handbook was last updated on October 31, 2018, to reflect changes implemented in the Fee-For-Service Medi-Cal network for the County of San Diego Behavioral Health Services Mental Health Plan (MHP).

■ No updates were completed this quarter (05/01/2019—07/31/2019)

**IMPORTANT:** The handbook is currently being revised to reflect the recent changes related to the CANS requirements and other verbiage. You will be notified as soon as a revised edition has been completed. Please ensure you are following the requirements per the <u>CANS Instructions and Process</u> on our website under the CANS tab.

# **New Review Tools and Reasons for Recoupment**

NEW OUTPATIENT REVIEW TOOLS! Be sure to go to our website <a href="https://www.optumsandiego.com">www.optumsandiego.com</a> and visit the Fee-For-Service page to ensure you are aware of the updates made to the site and treatment record review tools. This will help your practice remain compliant with County, State and Federal regulations.

Reminder: "Signature on file" is not accepted as a client signature on treatment plans, informed consents, consent for psychotropic medication, or releases of information.

Also, be sure to review DHCS Reasons for Recoupment, as they do change annually. We have created a quick guide for you which is located on our Fee for Service page of the website.

Some common Reasons for Recoupment include, but are not limited to:

- Failure to document medical necessity and impairment throughout entirety of record
- Progress note date does not match date of claimed service
  - There is no progress note present in record for date of claimed service
