





# Cerner Job Aid: COVID-19 Dashboard



A Vaccine Monitoring by Program Dashboard has been developed for outreach to clients. This Dashboard is formatted to show Fully Vaccinated, Partially Vaccinated, and Not Vaccinated clients, and is limited to the user's assigned program. This data is pulled from the San Diego Immunization Registry records.

1. To access the dashboard, select **All Projects** in the left hand menu.
2. Expand the **COVID-19 Data Discovery** project.
3. Select the **Vaccine Monitoring by Program** report under the **Reports** tab to open the dashboard.



Your program name will be listed in the dropdown menu below. If you are not assigned a program in HealthIntent, **(None)** will be displayed. If you are assigned more than one program, you may select a different program by expanding the dropdown and selecting a different program. You may also select and filter by Subunit for the selected program.

## Active Patients




This value represents the total number of active patients in the program

## Missing Numbers




This value represents the total number of clients where no phone number was found

## Overdue




This value represents the total number of clients who are overdue to receive their required 2nd dose




1. This value represents the total number of clients who have been fully vaccinated at the assigned program

# Cerner Job Aid: COVID-19 Dashboard



Clients have been broken out into two list: Partially Vaccinated and Not Vaccinated.

- The **Partially Vaccinated** list displays client contact information, their vaccine manufacturer, and their vaccination date
- The **Not Vaccinated** list displays client contact information only

## Frequently Asked Questions

- ◆ **Why do I not see the COVID-19 Data Discovery Project?**
  - ◇ In order to view the project, you need to be added to the project. Please reach out to [bhsdatasystems.hhsa@sdcounty.ca.gov](mailto:bhsdatasystems.hhsa@sdcounty.ca.gov) for assistance.
- ◆ **Where is the data coming from?**
  - ◇ The data is pulled from the San Diego Immunization Registry records. If vaccination data is not recorded in SDIR, then the client's vaccination data will not be displayed.
- ◆ **What clients are pulling into the dashboard?**
  - ◇ Client information is pulled from CCBH and SanWITS, and only pulls in patients that meet the following conditions: Age  $\geq$  16 years, alive, and have an open non-voided assignment (CCBH only).
- ◆ **When is a client considered fully vaccinated?**
  - ◇ A client is considered fully vaccinated when they've received 2 doses for both Pfizer and Moderna or have received 1 dose of Janssen, and are 2 weeks past their final dose date.
- ◆ **When is a client considered overdue?**
  - ◇ A client is considered overdue if it has been 21 days or more since their first Pfizer dose, or it has been 28 days or more since their first Moderna dose.
- ◆ **Why am I not seeing my program data?**
  - ◇ To see your program data, you need to be assigned to your program in the dashboard. Please fill out this form to request program assignment.
- ◆ **How can I print out the dashboard?**
  - ◇ The dashboard can be downloaded by selecting the  **Download** button in the top right corner of the dashboard. Options include:
    1. Image—A **.png** file of the current view will be downloaded
    2. Crosstab—After selecting the view to download, a **.csv** file of the summary data will be downloaded
    3. PDF—After selecting the view(s) to download, a **.pdf** file will be downloaded of the selected views
    4. PowerPoint—After selecting the view(s) to download, a **.pptx** file will be downloaded with each selected view as its own slide, as well as a title page slide
